On the date and time listed below, your vehicle was photographed driving through the listed intersection while the traffic signal was red. Pursuant to Section 316.0083(1)(b)1.a, Florida Statutes, the owner of a motor vehicle is liable for payment of \$158.00, if the owner's vehicle proceeds into an intersection equipped with a Traffic Control Signal Monitoring system with the traffic control signal for that vehicle's direction of travel is emitting a steady red signal and the motor vehicle did not come to a complete stop before proceeding into the intersection.

FAILURE TO PAY THE VIOLATION, REQUEST A HEARING OR PROVIDE AN AFFIDAVIT FOR AN APPEAL OR NOMINATED DRIVER WITHIN 60 DAYS OF THE DATE LISTED ON THIS NOTICE OF VIOLATION (DUE DATE) WILL RESULT IN A UNIFORM TRAFFIC CITATION ISSUED TO THE REGISTERED OWNER OF THE VEHICLE, RESULTING IN ADDITIONAL COURT COSTS, FEES AND POSSIBLE LOSS OF DRIVING PRIVILEGES.

Failure to pay the Notice of Violation, request a hearing or to furnish an affidavit pursuant to Section 316.0083(1)(b)1.a, Florida Statutes, within 60 days, the registered owner of the motor vehicle will be issued a Uniform Traffic Citation resulting in additional court fees, additional costs, and the possible loss of license.



Your vehicle was observed by a traffic infraction detector failing to comply with a steady red light signal, in violation of Florida Statutes §§ 316.0083, 316.074(1) and 316.075(1)(c)1, at the intersection, date and time stated on the front page of this Notice. This is a non-criminal infraction of state law. No points will be assessed, and this violation may not be used to set motor vehicle insurance rates.

Under Florida Statute § 316.0083, you, as the registered owner of the vehicle are responsible for the violation unless you can establish, by notarized affidavit, that an exemption from such responsibility applies. **You must either: (1) pay the penalty of \$158.00, as described below, (2) furnish a sworn affidavit that complies with the provisions of Florida Statute § 316.0083, or (3) request a hearing.**

**Failure to pay the violation, furnish an affidavit or request a hearing within 60 days following the date on this Notice of Violation (same as the Payment Due Date), the registered owner of the motor vehicle will be issued a Uniform Traffic Citation (UTC).** Once the UTC is issued, the fine will then increase to a minimum of \$264.00. Failure to pay the UTC may result in additional court costs, additional fees, and possible hold on the vehicle registration. **The submission of a false affidavit is a MISDEMEANOR of the second degree, punishable as provided in Florida Statute § 775.082 or § 775.083 by a term of imprisonment not to exceed sixty (60) days and/or a fine not to exceed \$500.00.** If your affidavit complies with the requirements of Florida Statute §316.0083, then no further action will be taken and you will receive a notice of dismissal or driver transfer. If it is determined that your affidavit does not comply with those requirements set forth in the statute or it is not received in time to process, then you will receive a Uniform Traffic Citation.

☐ **YIELDING RIGHT-OF-WAY**

My motor vehicle passed through the intersection in order to yield right-of-way to an emergency vehicle or was part of a funeral procession. ☐ **DIRECTED BY LAW ENFORCEMENT OFFICER**

My motor vehicle passed through the intersection at the direction of a law enforcement officer. An affidavit must be completed and executed in the presence of a notary. The affidavit can be downloaded at [www.public.cite-web.com](http://www.public.cite-web.com).

☐ **VEHICLE OWNER AFFIDAVIT OF NON-RESPONSIBILITY**

My motor vehicle was, at the time of the violation, in care, custody, or control of another person. An affidavit must be completed and executed in the presence of a notary. The affidavit can be downloaded at [www.public.cite-web.com](http://www.public.cite-web.com). You must include the name, address, date of birth, and if known, the driver's license number of the person who leased, rented, or otherwise had care, custody, or control of the motor vehicle at the time of the violation. The person you identify will be issued a Nominated Driver Notice of Violation.

☐ **STOLEN VEHICLE**

If the vehicle was stolen at the time of the violation, the affidavit must include the police report indicating that the vehicle was stolen. An affidavit must be completed and executed in the presence of a notary. The affidavit can be downloaded at [www.public.cite-web.com](http://www.public.cite-web.com).

☐ **UNIFORM TRAFFIC CITATION**

A law enforcement officer issued a Uniform Traffic Citation to the driver of the motor vehicle for the same violation at the location of the red light camera violation. Include the serial number of the Uniform Traffic Citation or for faster processing, you may, but are not required to, include a copy of the Uniform Traffic Citation. ☐ **I REQUEST A HEARING**

A hearing with Manatee County can be requested by completing a Request for Local Hearing. The form can be downloaded at [www.public.cite-web.com](http://www.public.cite-web.com). Mail the completed form to: Manatee County, Automated Red Light Enforcement System and Services, P.O. Box 1730, Denver, CO 80201-1730. A hearing will be scheduled with the Hearing Officer. You will receive written notification of the date and time for the hearing. A cancellation fee of \$50.00 will apply. In addition to the penalty prescribed under §316.0083 for violations which are upheld, additional court fees not to exceed \$250.00 will be applied.
